How could my out-of-pocket (OOP) drug costs change?

OOP drug costs are the expenses you have to pay for your prescriptions.

Voluntary Payment Plan

Opt in to **break your OOP costs into monthly installments**

\$2,100 OOP Maximum

You will **not pay more than \$2,100** in 2026 for all of your Part D-covered drugs (branded and generic)

\$0 OOP Costs

\$0 costs for all covered drugs if you reach the yearly OOP maximum of \$2,100

Consider managing drug costs with the Medicare Prescription Payment Plan

You might benefit from participating in the Medicare Prescription Payment Plan if you have high drug costs.



Opt in during Medicare open enrollment or anytime during the 2026 plan year



\$0 Pay nothing upfront at the pharmacy



Receive a bill from your health plan or Part D drug plan each month



Opt in to the Medicare Prescription Payment Plan during open enrollment to avoid higher OOP costs early in the year

How could your monthly Part D OOP costs change in 2026?^{4,6*†}




Mary is prescribed several branded medications, including one that treats overactive bladder. Her medications cost around \$15,000 per year, or roughly \$1,250 per month. Her plan has a \$615 deductible, plus a 25% coinsurance, up to the \$2,100 plan yearly OOP limit.

With the Medicare Prescription Payment Plan...



If Mary opted in to the **Medicare Prescription Payment Plan** during open enrollment, she could spread her \$2,100 OOP maximum into 12 monthly installments.[‡]



Without the Medicare Prescription Payment Plan...

Medicare's "Extra Help" program assists eligible Part D enrollees with OOP costs^{1,7}

- In 2026, those with Extra Help pay a **\$0 premium, \$0 deductible, \$12.65 copay for brand-name drugs**, and a \$5.10 copay for generic drugs⁶
- 1 in 4 people with Part D get Extra Help⁸
